

CAMPERSHIP PROGRAM PROCESS

Start Here - Read

- A copy of the Campership Application appears on the back of this page. Additional application forms will be available at all council offices and on the website www.ctrivers.org
- Connecticut Rivers Council administered Camperships will be restricted to Connecticut Rivers Council households only, which attend a Connecticut Rivers Council Camp Program, *subject to available funding*.
- Regardless of Family Adjusted Gross Income, if there are current extenuating financial situations, applications will be accepted with a detailed statement.
- Applicants are asked to forward complete applications by April 1, 2010 in a sealed envelope to the Campership Review Panel at the council office at PO Box 280098, East Hartford, CT 06128-0098 for review and processing.
- Any campership applications received after due date will be put into a pool of any remaining funds.
- **Unit Leader verification is required.**
- Except on rare occasions, Camperships are NOT granted for amounts greater than 50% of the Camp Fee.
- Unit leaders will be advised of Camperships pending and/or awarded, as to support unit accountability throughout the camp registration process. **Unit leaders will not be provided family's financial information.**
- Campership applicants will make camp payments to the unit* and are advised not to forward final payment until notice of campership award has been announced on or around May 1, 2010.
* For a Scout attending camp as a Provisional, or going to a Specialty camp, payments will be made directly to Connecticut Rivers Council.

- All applications **MUST** be submitted by April 1, 2010. Camperships are only given for ONE (1) camp session. File a separate application for EACH individual camper requesting a campership. Please CLEARLY PRINT all information. ALL QUESTIONS MUST BE ANSWERED, including ANNUAL INCOME.
- Camperships are RARELY granted in amounts greater than 50% of the total camp fee. FINAL camp payment IS NOT DUE TO UNIT* until notice of award has been announced on or around May 1st. **NO LATE CAMP FEES WILL BE CHARGED. FAILURE TO COMPLETE APPLICATION WILL CAUSE A DELAY.**
